INTRODUCTION

In 2001 the Florida Legislature established the Florida Center for Nursing (FCN) to address issues of supply and demand for nursing to include recruitment, retention, and utilization of nurse workforce resources. As defined by ss. 464.0195, Florida Statutes, the FCN is to develop a strategic statewide plan for nursing manpower in this state; convene groups representative of nurses and other health care providers, business and industry, consumers, legislators and educators; and enhance and promote recognition, reward, and renewal activities for nurses in the state. The Board of Directors designated the University of Central Florida to house the first and only Center for Nursing in the state.

VISION

The Florida Center for Nursing is nationally recognized as the definitive source for information, trends, research and forecasting about nurses and the dynamic nursing needs in Florida. The Center is the focal point for creating synergistic partnerships and collaborative efforts among stakeholders in healthcare delivery.

The MISSION of the Florida Center for Nursing is to:

- Address strategically the issues of nursing supply and demand to meet the needs of health care consumers in Florida;
- Generate and disseminate credible information to consumers of healthcare, professional organizations, healthcare providers, educational institutions, and legislators; and
- Enhance and promote innovative recognition, reward, and renewal activities for nurses and potential nurses.

ACCOMPLISHMENTS

The FCN is governed by a 16 member policy-setting board of directors appointed through the Office of the Governor. To facilitate the work of the center, a committee structure within the Board of Directors has been established to include Finance, Research, Public Relations, and Bylaws Committees. Since the FCN's Inaugural Meeting, held on March 1, 2002, the Board of Directors and staff have many accomplishments.

Workforce Summit

A nursing shortage data, information, and strategy development summit was held jointly with Workforce Florida, Inc. (WFI). In addition to FCN and WFI members, representatives of professional organizations, nurse executives, nurse educators, the FL Board of Nursing, the Agency for Workforce Innovation, the FL Department of Education, Regional WFI boards, and others participated in sharing of information and discussion. From this session, both WFI and FCN gained insight and direction to assist in formulating their future work.

Stakeholder Meetings

A total of six (6) information gathering events have been held in diverse regions of the state: Tallahassee, Miami, and Orlando. A variety of approaches were utilized such as in-person meetings, conference calls, and surveys conducted during conferences. Target audiences included:

- Nurse Administrators
- Nurse Educators
- Groups that collect information on nurses
- Direct care providers working in a variety of care settings (acute, long-term)
- Nurse Recruiters, Human Resource Directors, and Public Relations Professionals
